| Volltext                   | <p>The state subsidies are intended to support private providers in financing school expenses.</p> <p>Private primary and secondary schools that are operated by a legal entity under public or private law and operate on a non-profit basis are granted benefits for school expenses.</p> <p>For each school year, the school authorities receive a lump-sum grant per pupil and school year for the necessary school expenses.</p> <p>A two-year waiting period applies (exception: church schools).</p> <p>School authorities of private alternative schools are eligible to apply.</p> |
