Teaser	The Free State of Bavaria provides grants for the expenses of psychosocial AIDS counseling centers and for projects to prevent the immunodeficiency disease AIDS. Funding is also provided for further training measures for specialist staff and volunteers in AIDS work.
Volltext	<p>#### Purpose</p> <p>Appropriate measures are to be taken to inform the population about the dangers of the immunodeficiency disease AIDS, about infection routes and about how to avoid infection with the HI virus. Special attention should be paid to high-risk groups.</p> <p>Appropriate information should prevent stigmatization and exclusion of those affected.</p> <p>#### Object</p> <p>Funding is provided for psychosocial AIDS counseling centers as well as targeted projects for the prevention of the immunodeficiency disease AIDS and further training measures for specialist staff and volunteers in AIDS work.</p> <p>#### Recipients of funding</p>

	<p>The associations of independent welfare organizations and their affiliated organizations are eligible to apply, insofar as they are responsible for psychosocial AIDS counselling centres and other institutions, insofar as they are responsible for projects and measures.</p> <p>#### Eligible expenditure</p> <p>Depending on the object of the funding, personnel and/or material expenses can be funded.</p> <p>#### Type and scope</p> <p>Within the framework of project funding, grants are awarded in the form of fixed-amount funding (flat-rate funding) or grants in the form of pro rata funding, depending on the object of the funding.</p> <p>For projects for the prevention of the immunodeficiency disease AIDS, the grant amounts to up to 80% of the eligible expenditure.</p> <p>The project sponsor must provide an own contribution as prescribed by budgetary law.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • where appropriate, an informal declaration by partners in the action on the nature and extent of their participation
Voraussetzungen	<p>Essential funding requirements:</p> <ul style="list-style-type: none"> • Psychosocial AIDS counselling centres must assume the tasks described in the framework concept for the guideline on the funding of psychosocial AIDS counselling centres and the prevention of the immunodeficiency disease AIDS and meet the organizational requirements as well as provide the necessary personnel. • Other prevention measures and projects can be funded if there is a considerable need for the planned measure and the prevention goals cannot be achieved in any other way.

Applications must be submitted to the government responsible for the location of the measure.

Approval

The governments are responsible for approval. The governments submit applications for initial funding to the State Ministry for Health, Care and Prevention for a decision after checking the basic eligibility for funding. The approval period is the calendar year.

Bearbeitungsdauer
Frist

Initial applications for funding under Nos. 1 and 2 of the guidelines must be submitted to the granting authority by no later than November 15 of the year preceding the funding period applied for. Initial applications for funding under No. 3 must be submitted in a bundle by November 15 of the year preceding the funding period applied for at the latest. Funding applications for the continuation of existing measures and projects (follow-up applications) must be submitted to the granting authority by December 31 of the year preceding the funding period applied for.
