Municipalities and towns are eligible to apply.

Eligible costs

Funding is available for the costs of developing the concept.

Type and amount

Funding is provided as a grant (project funding).

Depending on the project and the financial strength of the municipality, the funding rate is up to 75%, up to a maximum of EUR 50,000.00 of the eligible costs.

The funding application must be submitted to the locally responsible Office for Rural Development.

Approval

Grants can only be approved if the project in question has not yet begun.

Bearbeitungsdauer

The responsible Office for Rural Development examines the application and approves the funding. The duration depends on the size and difficulty of the municipal area.
