Teaser	Inpatient care facilities and outpatient care services must submit an application for approval of the apportionment of separately calculable operationally necessary investment expenses if the facilities have received public funding (e.g. state, local authority).
Volltext	Inpatient care facilities and outpatient care services can charge those in need of care separately for necessary operational investment costs that are not fully covered by public funding. Subsidized inpatient care facilities and outpatient care services require the approval of the responsible government for this. Non-subsidized inpatient care facilities and outpatient care services are obliged to notify the responsible government of the amount of the investment cost rate.
