<b>Volltext</b>	The so-called self-disclosure from the population register is a special form of the right to information in accordance with Art. 15 of the General Data Protection Regulation. It is limited in the exceptional cases in accordance with Section 11 of the Federal Registration Act and by the prescribed deletion periods in the registration system.

<b>Verfahrensablauf</b>	You can apply for self-disclosure from the population register in person, in writing or electronically at the relevant registration authority.
