	on the Internet. On-site inspection at the municipality is also free of charge. Excerpts from the development plan or the land use plan can be obtained in print or digitally from the municipality for a fee.
Verfahrensablauf	Current development plans and effective land use plans should be made accessible by the municipalities via the central state portal and on the Internet. This is mandatory for documents relating to public participation procedures in accordance with Section 3 (2) of the Building Code. You can also request information about development plans or land use plans from the municipality. If you want to know more about land-use plans in the area of a property, you should be able to provide details of the property concerned (e.g. district, parcel number or address). You have a legal right to inspect the development plan and obtain information from the municipality. The claim can be asserted before the competent administrative court; the action for performance is relevant.
