Teaser	You need a rental car permit if you want to transport people commercially with rental cars. This does not refer to the rental of vehicles to self-drivers.
Volltext	<p>Transportation with rental cars is the transportation of persons with passenger cars that are only rented for transportation as a whole and with which the entrepreneur carries out journeys whose purpose, destination and course are determined by the renter and which are not transportation with cabs and not bundled on-demand transportation.</p> <p>This does not include the rental of vehicles to self-drivers.</p> <p>You may only hire out the vehicle as a whole. The hirer (passenger) determines the purpose, destination and schedule of the journeys.</p> <p>You can obtain the permit for a maximum of five years. After that, you can apply for an extension.</p> <p>Rental cars differ from cabs as follows:</p> <ul style="list-style-type: none"> <li>• You may not keep hire cars available in public places/roads for the transportation of passengers. They must return to the company's place of business after each transportation.</li> <li>• They have no obligation to operate or carry passengers.</li> <li>• The fare can be freely agreed. However, they must calculate it using a distance meter.</li> <li>• The color of the vehicles is not specified.</li> <li>• The number of permits is not limited.</li> <li>• You must affix a blue registration license plate to the rear window of your rental vehicle; the registration</li> </ul>

number is issued by the licensing authority.

**Erforderliche Unterlagen**

- The following documents are required for the rental car permit:
  - Proof of personal reliability (not older than three months at the time of application), e.g.:
    - Extract from the Federal Central Register (certificate of good conduct)
    - Information from the central commercial register
    - Extract from the central traffic register
    - Extract from the commercial or cooperative register (certified copies)
    - Copy of the articles of association and the list of shareholders
    - for legal entities: Proof of authorization to represent the company
  - Evidence of financial standing (not older than three months at the time of application):
    - Clearance certificates from the tax office
    - Certificate of no objection from the responsible municipality
    - Certificate of no objection from the social security authorities:
      - from health insurance companies with which you insure or have insured employees, and
      - for yourself, if you are or were voluntarily or privately insured.
    - Clearance certificate from the Employer's Liability Insurance Association for Transport and Traffic (not older than three months at the time of application).
    - Equity certificate and - if required - supplementary certificate (not older than twelve months at the time of application).
      - The amount of equity depends on the number of vehicles intended for use: For the first vehicle, you must provide evidence of equity capital in the amount of 2,250 euros, and for each additional vehicle, 1,250 euros.
  - Evidence of professional suitability:
    - Certificate of the specialist knowledge examination at the IHK or
    - Certificate of specialist knowledge from the IHK for at least three years of managerial activity in a rental car company or

<b>Kosten</b>	<p>Framework fee for the permit: EUR 50.00 - 500.00</p> <p>For regular cases it is</p> <ul style="list-style-type: none"> <li>• for the first vehicle: EUR 60</li> <li>• for each additional vehicle: EUR 30</li> </ul> <p>These amounts are not binding for the licensing authority.</p> <p>In the event of excessive administrative costs, the licensing authority may deviate from these amounts up to the maximum amount of the framework fee.</p> <p>You may incur further costs for register information and the preparation of other documents.</p>
<b>Verfahrensablauf</b>	<p>You must apply for the rental car permit at the responsible office. You can download an application form from the Internet, depending on the services</p>

	<p>offered by your competent authority.</p> <p>The competent authority will carry out a hearing procedure. As part of this, it requests opinions from other bodies, including</p> <ul style="list-style-type: none"> <li>• Municipalities,</li> <li>• trade supervisory authorities,</li> <li>• the Chamber of Industry and Commerce</li> <li>• the relevant trade unions and professional associations</li> </ul> <p>After the deadline for comments has expired, it makes a final decision on the application and informs the applicant of the outcome in writing.</p>
Bearbeitungsdauer	The responsible office will usually decide on your application within three months. The period can be extended by a maximum of a further three months. The prerequisite for this is that the competent authority has announced this in good time (within the first three months) in a written interim decision.
Frist	None Note: If you wish to apply for an extension of the permit, you must submit a permit application with the required documents to the competent authority in good time before the expiry of the expiring permit.
