For example, educational and family counseling centers can support you with Educational issues Personal or family-related problems relationship problems Questions and conflicts related to separation or divorce Developmental delays Sleep, eating and speech disorders Difficulties at school such as anxiety, performance problems and behavioral problems, especially during puberty Support in exercising contact
