Teaser	Successfully passing the tax consultant exam is a prerequisite for appointment as a tax consultant.
Volltext	The tax consultant examination is a state examination. Passing the exam is usually a necessary condition for appointment as a tax consultant. The exam consists of three written supervision papers and an oral exam. While the Chambers of Tax Advisors are responsible for the organizational implementation of the examination, the examination services are accepted by the state examination board of the Hamburg tax authority.

Voraussetzungen	They have - a successfully completed degree in economics or - university degree in law or - another university degree with a subject in economics and completed several years of practical work or They have - achieved a qualification in a commercial training occupation (e.g. tax clerk) or - achieved other equivalent training and proof of several years of professional experience or They are - in the financial administration as a senior civil servant or - as a

	comparable employee or - belonged to this and have/had worked there for several years as a clerk or in at least an equivalent position.
Kosten	Application for admission to the tax consultant examination: 300 EURO Examination fee for the tax consultant examination: 1,250 EURO Application for the issuance of binding information: 200 EURO Application for exemption from the tax advisor exam: 200 EURO
Verfahrensablauf	You submit the application to the Chamber of Tax Advisors. The Chamber of Tax Advisors is responsible for: - admission to the examination - Exemption from the exam - the organizational implementation of the examination Locally responsible is the Chamber of Tax Advisors in whose district you are primarily professionally active at the time you submit your application or if you are not working where you are resident.

Frist	The registration period for the tax consultant examination ends on April 30th of the respective examination year in which the applicant would like to take part.
