Volltext	If you want to invite a foreign visitor who needs a visa to enter the country, it is usually necessary for you to submit a declaration of commitment to Hamburg Service. With this declaration, you undertake to ensure the visitor's livelihood, including benefits in the event of illness, for the duration of your stay. You can only contact the Hamburg Service responsible for your place of residence. The Bergedorf and Billstedt locations are exceptions. There, please send an e-mail to the Department for Foreigners Affairs.
Erforderliche Unterlagen	The visitor is required to: exact personal details (first and last name, date and place of birth), Address abroad, The serial number of the passport is desirable. The host is required to provide: Natural people: ID card or passport, Evidence of financial capacity: Notices regarding child benefit, child supplement and/or parental allowance Employees: Wage or salary certificate or salary statement for the last month. Pensioners: current pension certificate Self-employed and freelance persons: last tax assessment (up to June of a year, the tax assessment from the year before last, from July of a year, the tax assessment from the previous year) and current profit and loss account as proof that the activity is still being carried out, or other evidence showing monthly net income or current monthly net profit (e.g. certified by a tax advisor). In the Altona and Blankenese locations, please also contact the Foreigners' Affairs location for declarations of commitment for self-employed persons. 	persons Extract from the commercial register (not older than 3 months), Profit and loss statement or other evidence (presentation by the managing director or an authorized representative).

Declaration of commitment, stay up to 3 months When inviting a foreign visitor who requires a visa to enter the country, it is usually necessary to submit a declaration of commitment. This declaration obliges the visitor to ensure his or her livelihood for the duration of the stay, including benefits in the event of illness. responsible: only the Hamburg Service location responsible for the place of residence. For the Bergedorf and Billstedt locations, please contact the Foreigners' Affairs location in advance by email for declarations of commitment. Declarations of commitment for more than 90 days are generally processed at the Foreigners' Affairs offices. For declarations of commitment for self-employed persons in the Altona and Blankenese locations, please contact the location for foreign affairs.
