Teaser	<p>The funding program helps you to modernize your building envelope in terms of energy. This way, you can save energy, conserve resources and reduce carbon dioxide emissions.</p>
Volltext	<p>The responsible body will support you in modernizing your building envelope. Both individual and multiple components are funded.</p> <p>The funding amount depends on the area being modernized.</p> <p>If you modernize components from different component groups at the same time, you will also receive a modernization bonus.</p> <p>The following measures are also supported:</p> <ul style="list-style-type: none"> • sustainable insulation materials, for example those with the "Blue Angel" quality mark or the "natureplus seal" • Quality assurance during construction: This includes support from experts, a hydraulic balancing of the heating system or an air tightness measurement
Erforderliche Unterlagen	<ul style="list-style-type: none"> • detailed construction description of the measure (tender documents or detailed cost estimate separated by trades, materials used)

- Proof or calculation of the thermal transmittance coefficients for the respective structure of the overall construction, for example external wall including plaster, load-bearing construction, insulation and, if applicable, air layers as well as cladding / external plaster; roof construction including rafters and under-/intermediate/on-rafter insulation; window, French door, roof window and external door installation with glazing including sash and frame profiles (according to standard boundary conditions of DIN EN 14351-1) in the tradesman's offer
 - if necessary, consulting contract from construction-accompanying experts from the list
 - if applicable, proof of the property being registered in the Hamburg monument list or proof that the property is located in the area of a regulation to preserve the composition of the residential population or to preserve the urban character of the area due to its urban design, as well as any resulting specifications or restrictions for the implementation of the measures applied for funding
 - if necessary, proof of the location of the object on the parcel boundary (development)
 - for internal insulation of external walls and flat roofs as a wooden construction, a declaration of structural safety
 - when promoting sustainable insulation materials, a corresponding current, valid certificate from the "Blue Angel" (RAL environmental label) or "natureplus seal"
 - for wooden windows and doors: information from the specialist company on the use of wooden products
 - if applicable, "de minimis" declaration
 - Declaration of de minimis aid already received and applied for
 - Photos of the front and back of the building or the component to be upgraded
 - Floor plan and, if applicable, other planning documents describing the project
 - when applying for the modernization bonus: quality-assured individual renovation schedule (iSFP), implementation assistance for the iSFP, detailed calculation documents according to DIN 4108-6 and DIN 4701-10 for the current condition and the renovation variant including representation of the component structures or a quality-assured Hamburg

Voraussetzungen	<ul style="list-style-type: none"> • You are a landowner or have other property rights, such as a leasehold right to a single-family home, a semi-detached house, a terraced house or a small apartment building (up to 2 rented residential units). • As a homeowners association (WEG), you can also apply for the subsidy. • You have not yet concluded any delivery and service contracts for the modernization. • They have not yet started modernizing. • They comply with the technical requirements of the funding guidelines.

Verfahrensablauf	<ul style="list-style-type: none"> • Please contact the responsible authority at an early stage with your request for initial advice. • You apply for the grant within the framework of the funding program via the online service **. ** • You register with the online service and can then log in with your user data. • Fill out the application form and submit your application. • As a homeowners association, you apply for the grant jointly. An authorized person signs the application for all members of the homeowners association. • The responsible authority will examine your application and documents. If necessary, it will request further documents or information from you. • The responsible authority will decide on your application. • You will receive a notification. • Once you have received approval, you can start your project and commission the trades. • Once the measures have been implemented, submit proof of use. • You will receive the subsidy. • Alternatively, you can apply for the grant by post to the responsible office with all the necessary documents. Use the application form to do so.

Frist	Do not start the project until your application has been approved. Do not sign any supply or service contracts beforehand. If necessary, submit missing documents or information within 3 months. Otherwise, your application may be rejected.
