Volltext	If a person owes you money from an enforcement title, e.g. a judgment or an enforcement order, and does not meet their payment obligation, you can commission a bailiff to enforce your monetary claim.

Sachverhalt

You can decide what the bailiff should do for you. This includes:

- conclusion of an installment payment agreement,
- Seizure of physical things and auction of these things,
- Acceptance of the asset information (formerly: affidavit),
- determination of the debtor,
- Determination of certain information about the debtor (e.g. determination of accounts or determination of the employer)

When **a seizure and transfer decision** is served, the (domicile) seat of the third-party debtor is decisive. We ask you to repeat the entry if necessary.

Inquiries can only be made in writing by post or fax. Processing by email is not possible.

The **fax no.** is timely.
