Teaser	If returning to your home country is impossible, you can obtain a temporary suspension of deportation (Duldung). Here you can find information about costs, procedures, and required documents.
Volltext	A temporary suspension of deportation is a document that allows you to stay in Germany temporarily, even if you are supposed to leave. This status can be granted if deportation is currently not possible, for example, because important documents are missing, you are ill, or it would be dangerous for you to stay in your country of origin.
Erforderliche Unterlagen	 Proof of identity (passport, ID card, ID card substitute) Proof of income, job, housing, social assistance, unemployment benefit
Voraussetzungen	Their deportation is currently not possible for factual or legal reasons.
Kosten	The issuance of a certificate of suspension of deportation (first issue) costs
Verfahrensablauf	 The responsible authority determines that you do not have a residence permit and are required to leave the country. The responsible authority will examine whether there are any reasons against your deportation. If there are obstacles to deportation, the responsible authority will issue a toleration permit. The competent authority checks at regular intervals whether the reasons for the toleration still exist or whether the situation has changed.

Hinweise	As a tolerated person, you are obligated to actively participate in the process (for example, in clarifying your identity, attending appointments, and assisting in obtaining necessary documents). Failure to cooperate may result in your tolerated status not being granted or not being renewed.
Rechtsbehelf	Contradiction
Kurztext	 Toleration allows you to stay in Germany temporarily, even if you are actually supposed to leave. important papers are missing Illness Danger in the country of origin Status can be granted if deportation is currently not possible Toleration is not a residence permit and does not give the right to stay permanently in Germany. Instead, deportation is suspended for a certain period of time; holders are still required to leave the country but are allowed to remain in Germany for the time being. Toleration can be actively applied for or granted as part of an official procedure Toleration is usually granted for a short period of time and is regularly extended.
