Volltext	If you want to work as a doctor in Germany, you need a separate professional license (approbation or professional permit). The approbation represents the more comprehensive professional authorization and entitles you to use the title of doctor. You must apply for the license to practice medicine from the responsible authority.
Erforderliche Unterlagen	• Application with declaration of pending criminal and investigative proceedings • Short, complete CV with date and signature • birth certificate • For married people, the marriage certificate or an extract from the family register • proof of identity (identity card, passport, travel document) • Medical certificate, which must not be older than three months at the time of granting the license.

	(Medical certificates from family members and life partners are not accepted) • Certificate of medical examination (must only be attached to the application if the license is not applied for before or shortly after the medical examination.)
Voraussetzungen	• You have successfully completed a degree in Germany or an equivalent qualification from abroad. • They are suitable in terms of health and personal characteristics. • You have sufficient knowledge of the German language.

Verfahrensablauf	• You apply for approval from the responsible authority. • If you received your degree in Germany, you can apply for approval online. • If you have completed your degree abroad, apply for approval in writing. • Any necessary forms can be found under the following links. • The responsible authority will inform you whether your application is complete or whether you need to submit further documents. • After a positive review, the responsible authority will grant approval and send you the approval certificate.
