Erforderliche Unterlagen	• ID card or passport • Professional license, certificate • Proof of professional training • Proof of professional career • Certificate of good conduct for submission to authorities • extract from the central Register of trade and commerce Evidence of the professional career of the company management and the nursing service management must be attached in the original or as a certified photocopy.
Voraussetzungen	Anyone wishing to open a nursing service has to present a target-group-oriented nursing concept, in the case of care for residential communities, the number and number of users, the planned number of employees, information material for the nursing staff and the qualifications of the company management and the nursing service management.
