Kosten

Fees are charged in accordance with the environmental fee regulations. The amount may depend on the value of the genetic engineering facility. You can find out the exact amount in advance from the responsible authority.

Verfahrensablauf

Bearbeitungsdauer

The processing time varies depending on the type of procedure. If all the required documents and the safety classification by the Central Commission for Biological Safety are available, the responsible body will decide on your application for approval within 90 days.

Frist

You need the permit before you can start constructing or operating the genetic engineering facilities.
