Teaser	Has the use of certain work equipment resulted in damage to certain equipment or injury to a person in your company or building? You must report this to the relevant authority.
Volltext	<p>If the use of work equipment results in the failure of components or safety devices, damage to certain systems, or a person is seriously injured or killed, you as the employer must report this to the responsible authority.</p> <p>These specific work equipment includes systems requiring monitoring such as,</p> <ul style="list-style-type: none"> <li>• cranes</li> <li>• LPG systems</li> <li>• mechanical work equipment for event technology</li> <li>• elevator systems</li> <li>• printing systems</li> <li>• systems in potentially explosive areas</li> </ul>
Erforderliche Unterlagen	<p>Informal notification with the following information:</p> <p>company address</p> <p>Address of the business premises or the construction or assembly site at the event location</p> <p>date of the event</p> <p>Type of event, for example explosion, media leak, crash</p> <p>Number of injured people, number of killed people</p>

	<p>Work equipment involved  included approved monitoring body (for systems requiring monitoring according to Annex 2 of the Industrial Safety Ordinance)  involved body for determining the cause (for work equipment according to Annex 3 of the Industrial Safety Ordinance)  Brief description of the event and the damage that occurred (including photos and videos) measures already taken by the employer  The competent authority may also request the following information from you:</p> <ul style="list-style-type: none"> <li>• risk assessment</li> <li>• Proof that a qualified person has prepared the risk assessment</li> <li>• Information about the responsible persons</li> <li>• information on protective measures taken</li> <li>• Evidence of regular training of employees</li> <li>• operating instructions</li> </ul>
Voraussetzungen	<p>You are an employer.  The following tools are involved:</p> <ul style="list-style-type: none"> <li>• elevator systems</li> <li>• printing systems</li> <li>• systems in potentially explosive areas</li> <li>• cranes</li> <li>• LPG systems</li> <li>• mechanical work equipment for event technology</li> </ul> <p>It must be a case of damage in which components or safety devices have failed.</p>

Verfahrensablauf	<ul style="list-style-type: none"> <li>• Immediately submit the report of the event to the competent authority in writing or by email, along with all required information.</li> <li>• The ad is being reviewed.</li> <li>• The competent authority will inform you whether further documentation (for example an assessment by an approved inspection body) is required.</li> <li>• The accident will be investigated if necessary.</li> </ul>
Bearbeitungsdauer	The responsible authority will contact you immediately.

Kurztext	<p>Damage caused by failure of components or safety equipment must be reported to the occupational safety authority.</p> <p>Industrial accidents in which a person is injured or killed must be reported to the occupational safety authority</p> <p>Prerequisite: The following tools are involved</p> <ul style="list-style-type: none"> <li>• elevator systems</li> <li>• printing systems</li> <li>• systems in potentially explosive areas</li> <li>• cranes</li> <li>• LPG systems</li> <li>• mechanical work equipment for event technology</li> </ul> <p>Notification must be made immediately, is informal, free of charge and can be sent by email.</p>
