| Volltext                      | Exceptions can be granted if a blocked or weight-restricted road is to be used regularly or for a certain period of time. Before a permit can be issued, the approval of the locally responsible police station is required, which the LBV will obtain if an exemption is to be applied for for longer than 3 months.                                                                                                                  |

| Voraussetzungen               | <p>The following information is required:</p> <ul style="list-style-type: none"> <li>• Justification for the purpose of using the vehicle</li> <li>• Information on the activities to be carried out</li> <li>• License number</li> </ul> <p>If necessary, more detailed information on the location is required if an exemption is only requested for certain streets or, for example, a pedestrian zone.</p>                         |
| Kosten                        | The fee is 110 euros per year (non-binding fee information).
