Voraussetzungen	<p>You must register with the contribution service, · if you are of legal age (18 years or older) and · if you or someone else has not yet paid the license fee for your home. There is no obligation to pay a fee for an empty apartment. Requirement is, · that this is not inhabited by anyone, · that there is no rental agreement for them and · that no one is registered with the residents' registration office for them.</p>
Kosten	<p>For citizens: · per apartment: EUR 17.50 per month · Each additional apartment: EUR 17.50 per month · Reduced license fee: EUR 5.83 per month You have to pay the license fee for three months at a time. The contribution service collects it in the middle of a three-month period.</p>
