Teaser	If you want to build, modify and/or change the use of a structure, you need a building permit.

Kosten	Gebühr: 65€ - 130€ In the case of new buildings, conversions and extensions, the fees are based on the eligible costs or the production costs.

	Minimum fee: EUR 64.70 in the simplified approval procedure Minimum fee: EUR 129.40 in the concentrated approval procedure
Verfahrensablauf	<ul> <li>You or your person authorized to submit building plans submit an application for approval to the responsible authority. An online service is available for this purpose.</li> <li>The responsible authority will examine your application and, if necessary, request any necessary documents or information from you.</li> <li>You will receive a written approval or rejection notice.</li> <li>You will receive a fee notice and pay the fees</li> </ul>
Bearbeitungsdauer	The processing time depends on the scope of the project applied for and the type of procedure chosen and can take 1-3 months after the required documents have been submitted in full.

A complete building application is an essential prerequisite for the smooth running of the process. An application may only be submitted by a person authorized to submit building plans (usually an architect or a civil engineer).

When applying for a building permit, you can choose between the simplified procedure and the concentrated procedure. In the simplified procedure, it is your responsibility to obtain any other necessary permits from other authorities. You must check for yourself whether all legal areas of the building regulations and ancillary building law are complied with. If you want to have everything from a single source, you should choose the concentrated procedure.

If there are doubts about the basic approval of the building project, you can have these clarified at an early stage with a preliminary building permit. However, this only answers individual questions and does not replace the required building permit.

Advice outside of ongoing approval procedures is subject to a charge.

In Hamburg, as of January 1, 2024, all applications in the following procedures must be submitted via the online service "Building Application 2.0". Submitting an application in paper form is no longer possible.

- Building permit in simplified procedure
- Building permit in concentrated procedure
- Preliminary building permit
- Consent procedure
- Approval of deviations, exceptions and exemptions from the provisions of the Hamburg Building Code (HBauO)
