Teaser	As a citizen of Switzerland, you can personally report your stay to the immigration authorities in order to obtain a residence permit. Your family members who are not Swiss nationals must report this within three months of entering the country.
Volltext	As a Swiss citizen, you are exempt from the requirement for a residence permit due to the Agreement on the Free Movement of Persons between the EU, its member states and Switzerland, but you can apply for a residence permit to be issued as an electronic residence permit (eAT) if you wish. Your right of residence exists as long as you meet the requirements specified in the agreement. This is the case, for example, as long as you are employed in Germany, study here, are self-employed or can simply live on your savings here without state aid. Your family members who are not Swiss nationals must report their stay to the Office for Foreigners' Affairs within 3 months of entering the country. If there is a right to

Erforderliche Unterlagen	<p>valid passport or ID card for Swiss nationals valid passport for family members of the Swiss national</p> <p>Biometric passport photo: The photo must be up to date and meet the photo requirements for electronic ID cards. Evidence of entitlement to the right to free movement (original and copy): Employee: employment contract or commitment to employment</p> <p>Self-employed: Business registration from the trade office, possibly orders, invoices or similar Freelancer: Tax number from the tax office, if necessary orders, invoices or similar Students: Admission from the university or certificate of enrollment, proof of sufficient means of subsistence and health insurance</p> <p>Non-employed persons: Proof of sufficient means of subsistence and health insurance Family members need proof of their family relationship with the Swiss citizen, eg birth certificate, marriage certificate, registered same-sex partnership, documents on custody of minor children</p>

Verfahrensablauf	<p>You make an appointment at the responsible location for foreigners' affairs of the district office in which you are registered They demonstrate their right to freedom of movement The immigration authorities will check whether you meet the requirements of the right to freedom of movement. You will be invited by the responsible office for foreigner affairs to give your fingerprints. You can pick up the electronic residence permit about 4 weeks later</p>

Bearbeitungsdauer	The processing time is between 5 and 12 weeks. This depends on the duration of the appointments in the respective responsible location for foreigner affairs.

Hinweise	Only electronic residence permits (eAT) are issued in the form of a check card with additional electronic functions.
Rechtsbehelf	Before the decision on the assessment notice is made, you must be heard in accordance with Section 28 of the Hamburg Administrative Procedures Act (HmbVwVfG). You can lodge an objection to the deportation order within one month of notification with the office issued (§§ 79 HmbVwVfG, 70 Administrative Court Code (VwGO)). You can file a complaint against the rejection notice with the Hamburg Administrative Court, Lübeckertordamm 4, 20099 Hamburg within one month (§§ 79 HmbVwVfG, 74 VwGO).

Kurztext	<p>Residence permit for Swiss nationals According to § 28 AufenthV, Swiss nationals are exempt from the requirement of a residence permit. If a Swiss citizen wishes to be issued with a residence permit, a residence permit will be issued as an electronic residence permit (eAT) in accordance with section 78 (1) sentence 2 of the Residence Act. The Swiss residence permit has a purely confirmatory character.
