| Volltext                      | You must wear a seat belt while driving and a helmet when riding a motorcycle. This requirement may be waived if you are unable to wear a seat belt or helmet for health reasons. You may also be exempt from the seat belt requirement if you are less than 150 cm tall. You can apply for an exemption for this.                                                                       |
