Teaser	If your vehicle is exempt from vehicle tax, you can apply for a green license plate.
Volltext	If your vehicle is exempt from vehicle tax, it will receive a green license plate. This includes vehicles from various industries, such as agriculture and forestry, fairground rides, or ambulances. A list of other vehicles can be found in Section 3 et seq. of the Motor Vehicle Tax Act (KraftStG). Trailers receive a green license plate if they are taxed via the towing vehicle. Exempt vehicles that do not receive a green license plate despite being tax-exempt include vehicles owned by severely disabled persons, low-emission vehicles, and light and small motorcycles.
Erforderliche Unterlagen	Application for allocation of a green license plate (available locally) Registration certificate part I (vehicle registration document) the black license plates if the vehicle is still registered further documents according to the type of registration (e.g. transfer, new registration, etc.)
Voraussetzungen	Your vehicle is exempt from vehicle tax. The main customs office decides on this. There is no exception to Section 9 Paragraph 2 of the Vehicle Licensing Ordinance (FZV).
Kosten	The fees depend on the type of registration (e.g. transfer, new registration, etc.).
Verfahrensablauf	Book an appointment online. Book the appointment that best fits your needs on our website. This appointment must be arranged during the registration

	process. There is no specific appointment type for this license plate number. You will receive an email. Confirm your reservation using the link in the email. Bring all necessary documents and the appointment confirmation with you to your appointment at the LBV. Scan the QR code on your appointment confirmation using the scanner on site. Take a seat in the waiting area. You will be called by your call number. Your request is being processed. The LBV will forward your application to the Main Customs Office, which will then make the final decision on your application. The main customs office will then contact you.
