Volltext	They provide commercial assistance in tax matters in accordance with the provisions of this Tax Advice Act. Your task is to advise your clients on tax matters, to represent them and to assist them in processing their tax matters and in fulfilling their tax obligations. As a tax advisor, you are an independent body in the administration of tax law and need to be appointed by the responsible Chamber of Tax Advisors.
Erforderliche Unterlagen	The following documents must be submitted for the first appointment as a tax advisor at the Hamburg Chamber of Tax Advisors: - Application for appointment as a tax advisor including passport photo - certified copy of the successfully passed tax advisor examination or exemption from this examination - Proof of sufficient professional liability insurance - Current certificate of good conduct with document type zero
Voraussetzungen	You, as a tax advisor: - are in their own orderly economic circumstances - have no criminal convictions and are therefore able to hold public office - have no health problems - have successfully passed the tax advisor exam - do not carry out any activity that is incompatible with the profession of tax advisor - have a guarantee of coverage from a professional liability insurer
Kosten	Processing fee of 125.00 EURO
Verfahrensablauf	You must submit the application to the Hamburg Chamber of Tax Consultants if the location of the German branch is Hamburg.
