Volltext	<p>The professional title of "paramedic" is regulated in Germany. This means that you may only practice this profession with a government permit. This permit entitles you to use the professional title of "paramedic" and to work in this profession.</p> <p>If you have a comparable foreign qualification and want to work as a paramedic in Germany, you must apply for recognition of your foreign professional qualification.</p>

Voraussetzungen	<ul style="list-style-type: none"> • There are no significant differences between your professional qualifications and the paramedic training in Germany. • If there are significant differences, you can compensate for them by completing an adaptation course or taking an aptitude test.
Kosten	EUR 45.00 - EUR 350.00. If your application is rejected, 75% of the fees will be charged.
Verfahrensablauf	<ul style="list-style-type: none"> • You submit your application along with the necessary documents to the responsible authority. • The responsible authority will examine your application and inform you of the decision in writing.
