Teaser	In order to transport passengers commercially, you need a driver's license for passenger transport (passenger transport license).
Volltext	If you want to transport passengers commercially, you need a passenger transport license. This includes the following journeys:

- Taxis
- Rental cars or cars in scheduled services or bundled on-demand transport
- Rental car or car for commercial excursions and holiday destinations
- Ambulances if you transport people for a fee or commercially

You need a permit to transport passengers in addition to your driver's license. You must apply for the permit. If you have a Class D driver's license, you do not need one.\*\*\*\* separate driving license for passenger transport.

## Erforderliche Unterlagen

- a valid identity card or an electronic residence permit (eAT) or passport with a current confirmation of registration
- a German EU card driving license (issued after 19 January 2013; older driving licenses must be exchanged beforehand)
- an ophthalmological report in accordance with Annex 6.2 of the Driving Licence Ordinance (FeV), not older than two years
- a medical report in accordance with Annex 5.1 FeV, not older than one year
- a medical report in accordance with Annex 5.2 FeV, not older than one year (occupational or company physician)
- a certificate of good conduct that is not older than three months at the time of application (feature O for official purposes, to be applied for at the registration authority)
- the appointment confirmation

Additionally when applying for ambulance:

- Proof of participation in a first aid training course

## Voraussetzungen

- You have the necessary personal reliability.
- You have the necessary physical and mental fitness.
- You have sufficient eyesight.
- You have a German Class B driving license in the format of the new EU card driving license (issued from

	<p>January 19, 2013).</p> <ul style="list-style-type: none"> <li>• If your driver's license was issued before this date, you must exchange it beforehand. You must also exchange a foreign driver's license beforehand.</li> <li>• You have your main residence in Hamburg.</li> <li>• You are at least 21 years old. (The minimum age for ambulance drivers is 19.)</li> <li>• You have held a Class B driving licence for at least 2 years within the last 5 years (one year is sufficient for ambulances)</li> </ul>
Kosten	<p>45.40 EUR</p> <p>If the old driver's license also needs to be exchanged for the EU card driver's license, additional fees of between EUR 26.50 and EUR 65.70 will apply. The exact exchange costs can only be determined after reviewing all the documents. The fee amount is based on the German Fee Schedule for Measures in Road Traffic (GebOSt).</p>
Verfahrensablauf	<ul style="list-style-type: none"> <li>• You book an appointment online.</li> <li>• You bring all the necessary documents with you.</li> <li>• The application will be completed during your appointment and your request will be processed on site.</li> <li>• If all necessary documents are available and the requirements are met, your driver's license for passenger transport will be issued to you immediately.</li> </ul>
Bearbeitungsdauer	Usually immediately.
Frist	The driving licence for passenger transport is currently issued for a maximum of 2 years (until there is a new regulation regarding proof of the specialist knowledge test). This should be renewed in good time (4 to 6 weeks before the expiry date).

A driving license for passenger transport is also not required.**** required for:</p> <ul style="list-style-type: none"> <li>• Ambulances of the Bundeswehr, the Federal Police, the police as well as the troops and civilian entourage of the other states party to the North Atlantic Treaty Organization (NATO),</li> <li>• Ambulances of the civil protection service, if they are used for this purpose,</li> <li>• Ambulances of the fire departments and rescue services recognized under state law.</li> </ul> <p>You can find occupational and company physicians for the examination in accordance with Annex 5 FeV through the Medical Association.</p> <p>Appointment booking</p> <ul style="list-style-type: none"> <li>• You visit the website of the State Office for Transport to book an appointment (see link below).</li> <li>• Select the category: Driving license</li> <li>• Then select: Application for passenger transport ticket</li> <li>• Follow the steps below to reserve an appointment. You can apply at the LBV Central and North locations.</li> <li>• You will receive an email.
