Teaser	Here you will find information on the registration of a building burden.
Volltext	Building encumbrances are requirements that you as the owner of a property must comply with. Building encumbrances tell you what you must do, allow or not allow on your property.
Erforderliche Unterlagen	The documents required vary depending on the type and scope of your application. The responsible authority can inform you accordingly.
Voraussetzungen	• There is a legitimate reason for the registration of the building burden (e.g. construction project, change of use of a property, public interests) • The building burden must be in the public interest, for example with regard to the development of the property, the protection of environmental resources or the security of public order (for example fire protection).
Kosten	Gebühr: 62€ - 1.000€ 66.84 EUR - 1,000.00 EUR
Verfahrensablauf	• You submit an application (for example: granting a building permit, approval of a change of use or registration of a building burden) and provide the necessary documents. • The responsible authority will examine your application and, if necessary, request any missing documents or information from you. • If all requirements are met, the building burden is entered in the building burden register. • You will receive written notification of the decision. • You pay the applicable fees.
