Hinweise	The compensation is based on the loss of earnings. For the first six weeks, it is granted in the amount of the loss of earnings. From the beginning of the seventh week onwards, it is paid in the amount of sick pay. In the case of employees, the employer must pay compensation to the competent authority for the duration of the employment relationship, for a maximum of six weeks. The amounts paid will be reimbursed to the employer by the competent authority upon request.
