Teaser	If you are accused of a traffic violation, you have the opportunity to comment on it.
Volltext	If you have been informed by letter that you have committed a traffic violation, you will also be informed that you can attend the hearing. The hearing will give you the opportunity to comment on the accusation. The hearing will give you the opportunity to: to comment on an allegation and to take a position to appoint another driver to change personal data (for example, address when moving) to view evidence photos online upload attachments You are not obliged to use the opportunity to attend a hearing. If you have committed an offence that is subject to a fine, you do not have to provide any information online. It is sufficient if you pay the fine on time. If a fine procedure has already been initiated, the fine notice may be issued more quickly if you use the hearing and admit that you have committed the offence.

Voraussetzungen	You are accused of a traffic violation.

Verfahrensablauf	The responsible authority sends you a notification that you have committed a traffic violation. The letter will inform you that you can comment on the allegation (hearing) or, if necessary, close the case by paying a fine. You can provide your information in writing on the hearing form or online. If you would like to provide the information in writing, fill in the fields on the hearing form and then send it by post to the

	responsible office. You will not receive a confirmation that your information has been received. If you would like to provide the information online, follow the link provided in the letter and enter the access code provided in the letter. Then fill in the required fields and click on the "Submit" button. You can then download the record of your information. After reviewing your information, the responsible authority will inform you whether the allegation still stands.
Bearbeitungsdauer	The processing time varies depending on the individual case.
Frist	You can submit the request for a hearing or pay the fine within one week of receiving the letter.

In this case, select "no" under "Admit violation". Please provide the file number with all punctuation marks included. You can obtain further information about the online hearing by calling 428 39 3333. This is a recorded message that answers the most frequently asked questions (FAQs).

Rechtsbehelf

A hearing is a statement from you. No legal remedy is provided. Legal remedies are permissible in any subsequent proceedings.

Kurztext

Notification of a traffic violation is sent by letter The opportunity to be heard is granted to comment on the charge Functions of the hearing: Statement and statement on the accusation Naming another driver Change of personal data, e.g. address when moving viewing of evidence photos online Uploading attachments Use of the hearing is not mandatory In the case of administrative offences involving fines, no online declaration is necessary; timely payment of the fine is sufficient In the penalty procedure, the hearing can enable a faster issuance of the penalty notice if the offence is admitted
