Teaser	If you have another apartment, you must register it for the broadcasting fee. The fee is generally due for each apartment.
Volltext	The broadcasting fee is a monthly fee that every household in Germany must pay to finance public broadcasters such as ARD, ZDF and Deutschlandradio. The contribution applies to all households, regardless of whether you listen to the radio or watch television. If you rent or buy another apartment in addition to your main residence, you must register it with the contribution service. This also applies to holiday homes and caravans if you use them primarily for private purposes at a fixed location. In certain cases, you can apply for an exemption from the broadcasting fee for your secondary residence if your main residence is already subject to the fee.
Erforderliche Unterlagen	informal letter by post or completed registration form on the Internet Form: Registration of an apartment
Voraussetzungen	You are of legal age. You have already registered an existing apartment.
Kosten	Your registration for the broadcasting fee is free of charge. The broadcasting fee is currently 18.36 euros per month. The reduced broadcasting fee is currently 6.12 euros per month.
Verfahrensablauf	You register your apartment with the responsible authority for the broadcasting fee. The responsible authority will examine your application and documents. If necessary, it will request further documents or information from you. The responsible authority will decide on your application. You will receive a notification.

Bearbeitungsdauer	Processing this application usually takes about 6 to 8 weeks.
Frist	Payment of the broadcasting fee begins on the first day of the month in which you move into an apartment. This means: They live there, You are registered there or Your name appears on the rental agreement as the tenant. As soon as one of these conditions is met, the obligation to pay contributions begins.

Hinweise	If you have previously paid broadcasting fees, these will automatically be converted to the broadcasting fee. You will usually receive a letter from the fee service. If you are no longer required to pay the fee, for example because another resident in the apartment is already paying the broadcasting fee, you can deregister with the contribution service.
