Volltext	As a measuring point for emissions and immissions in accordance with the Federal Immission Control Act, you can offer your services throughout Germany following approval and notification by a state authority or participate in corresponding tenders.

Voraussetzungen	As the notifying body you are:
	 a partnership under civil law or a legal entity: Joint-stock company) Limited liability company (GmbH) cooperative Association Authority and other public institution. As a general partnership (OHG) or a limited partnership (KG and GmbH & Co. KG) you are treated the same as a legal entity.
	You need the necessary expertise to be approved as a measuring point. You also need to be reliable and independent.
	You must have the equipment and personnel to identify the substances for which you wish to be notified.

Kosten	You will receive a fee notice. The fees depend on the examination and administrative effort.
Verfahrensablauf	Apply for approval from the responsible authority. To do this, use the nationwide application form. It is available for download on the Internet: https://www.resymesa.de/ReSyMeSa/Stelle/Fachinformation?modulTyp=ImmissionsschutzStelle If all requirements are met, you will be recognized as a "notified body in accordance with Section 29b BImSchG" with a formal notification from the responsible body. Your announcement will be published nationwide in the Internet database ReSyMeSa - research system for measuring points and experts.
Bearbeitungsdauer	You will receive notification of your announcement approximately four months after the complete documents have been submitted.

Frist	The notification is limited to five years and must then be applied for again.

Hinweise	Certain emissions and immissions of noise, vibrations and air pollutants may only be determined by expert bodies, for example measuring institutes. The same applies to checking the correct installation and function of the measuring equipment during continuous measurement of the system. For these activities, appropriate accreditation in accordance with DIN EN 17025 is a prerequisite. For the calibration of measuring equipment in the chimney sweeping industry, a certificate according to VDI 4208, Sheet 2 on the establishment of a quality assurance system is required instead of accreditation.
