Teaser	If you want to fish using electricity, you must apply for a permit in advance.
Volltext	You must apply for approval in advance from the responsible authority. You must have the permit before you start electrofishing.
	Justification that electrofishing is necessary for the sustainable management of a fishing water or for the purposes of fisheries science, nature conservation or other necessary fisheries biology studies Proof of attending a recognized electrofishing course in the Federal Republic of Germany Proof of sufficient liability insurance A certificate, no more than 3 years old, that the electric fishing tackle complies with the regulations of the Association of German Electrical Engineers
Voraussetzungen	You can justify and prove why fishing with electricity is necessary. You have completed a course in electrofishing and can provide evidence of this. You have sufficient liability insurance and can prove this.
Kosten	Permit: EUR 50.00 Per body of water in which electrofishing is to be carried out: an additional EUR 5.00
Verfahrensablauf	In order to receive approval, you must submit an informal, written application to the responsible authority. Approval will be granted to you by the responsible authority after checking all legal and factual requirements.
Bearbeitungsdauer	Up to one week.

Hinweise	The fishing equipment used for electrofishing must comply with the regulations of the Association of German Electrical Engineers.
Rechtsbehelf	An objection can be lodged against the decision within one month.
Kurztext	Apply for fishing with electricity Anyone who wants to fish with electricity needs a permit from the responsible authority. The permit is granted if it can be proven that fishing using electricity is necessary. In order to obtain the permit, you must first complete an electrofishing course. As an electric fisherman you need sufficient liability insurance. The fishing equipment used for electrofishing must comply with the regulations of the Association of German Electrical Engineers.
