Teaser	If you intend to reduce the forest density on a forest area, you need prior approval above a certain extent.
Volltext	If you intend carry out a clear cut on an area of more than 0.5 hectares or to carry out a clear cut on an area of more than 0.5 hectares, which is equivalent to a clear cut; or reduce tillering to a value below 0.6, then you need the approval of the competent authority. You can apply for permission from the competent authority. You must have the approval before the action is carried out.
Erforderliche Unterlagen	Information on the plot / forest location (field map, description of location, size of area) Information on the type and scope of the planned measure Information on the objectives of the measure Justification why the objectives cannot be achieved in any other way If necessary, other forestry data and documents that the competent authority requests from you during the approval process.
Voraussetzungen	The measure must be necessary for forestry purposes and must not restrict the protective function of the forest. After the measure, the forest is to be reforested if the natural stocking remains incomplete.

Verfahrensablauf	In order to obtain a permit, you must apply to the competent authority and submit the necessary documents. The application can be made informally. The competent authority will examine your application

Hinweise	The clear cut, the clear cut or the lowering of the tillering degree may only be carried out when the permit has become final. If there are conditions associated with the approval, these must also first be fulfilled before the measure can be started.
Rechtsbehelf	Objections to this decision can be raised within one month of delivery.
Kurztext	Apply for a clear cut permit A permit from the competent authority is required to carry out a clear cut on an area of more than 0.5 ha. A light cut on an area of more than 0.5 ha can resemble a clear cut, and then also requires a permit from the responsible authority. Reducing the tillering level to a value below 0.6 can be like a clear cut and then also requires the approval of the responsible authority. The measure must be necessary for forestry purposes and must not restrict
