You submit the report to the responsible authority. The responsible body will check your report for plausibility. The responsible body will forward your report to the Federal Environment Agency. The Federal Environment Agency forwards your report to the European Commission.
Bearbeitungsdauer	The processing time is not specified by law.
Frist	They shall submit the report annually to the competent authority for each individual installation by 30 April of the following year. The competent authority will forward your report to the Federal Environment Agency by 31 October of the year following the reporting year.
