Volltext	<p>For example, if you want to hold an event at your airport where aircraft are displayed in flight or compete against each other, then you need a permit. You must apply for this at the responsible authority. Aviation events are particularly dangerous due to the increased traffic density and large number of visitors. They must therefore be meticulously planned, meticulously carried out and strictly controlled. The responsible aviation authority checks whether the program and the participants offer a guarantee for the safe execution of the event and regulates the necessary safety and noise protection precautions in the event of the event being approved. During the event, the aviation authority will monitor compliance with these requirements.</p>

Completed application for approval of an aviation event  
 Consent of the airport operator (unless the organizer is also the airport operator)  
 Aviation event located outside an aerodrome: Proof of right of use  
 Sketch of the prospective site with indication of its dimensions and a report on its suitability 1:25000 scale map  
 Site plan on a scale of 1:1500 to 1:5000 with the event site marked. The dimensions of the event site, take-off and landing areas, the locations of the rescue services and the doctor as well as parking spaces and the barriers are to be drawn into the plan. Program of the event including flight program  
 Air traffic control information (description of the airspace or routing required for the aviation event)  
 At the request of the competent authority: Security concept including emergency planning  
 Flight operations instructions from the person in charge of the event  
 Names and pilot's licenses or officially certified copies of the pilot's licenses of the pilots involved  
 Agreements of the organizer with the pilots, air carriers, other parties involved in the flight demonstrations in the air and on the ground and with the liability and accident insurance  
 Proof of organizer liability insurance  
 Proof of ground accident insurance  
 Proof of continuous flight exercises of the participating aerobatic pilots  
 Expert opinion on the suitability of the event site

**Voraussetzungen**

As the organizer, you must take out organizer liability insurance to cover any third-party damage. The aviation event must not endanger public security or order.

**Verfahrensablauf**

If you are planning an event with aircraft: Submit all required documents with your application. The competent authority will carry out an examination of your application. It will be checked whether the program and the participants ensure that the event can be carried out safely. After examining the documents, the responsible authority decides whether you will receive permission to hold the aviation event. You will receive a notification of approval or rejection (by post or, if necessary, via the service portal of the responsible authority). In the event of an event being

	approved, the responsible body regulates the necessary safety and noise protection measures. During the event, the responsible body monitors compliance with these requirements.

Hinweise	You do not need a permit for aviation events in which only model aircraft and non-motorized air sports equipment take part within the framework of an ascent permit that has already been issued, which are not subject to the obligation to be licensed for traffic and with which no passengers are transported.
Rechtsbehelf	contradiction
Kurztext	Aviation events are associated with special risks. They have to be planned and carried out precisely and controlled precisely. They place special demands on the reliability of the organizer and the participating pilots. No aviation event may take place without permission. You can apply for this permission. It will be checked whether the program and the participants offer a guarantee for the safe implementation of the event. If an event is approved, the necessary safety and noise protection measures will be taken. Compliance with these requirements will be monitored during the event.
