Teaser	You can receive financial support to prevent and combat damage caused by epizootics or other animal diseases, as well as for measures from monitoring and animal health programs.
Volltext	You can receive financial support for measures to prevent, control, monitor and eradicate animal diseases, epidemic animal diseases or zoonoses in cattle, sheep, goats, pigs and horses. This also applies to measures under surveillance and animal health programmes. This support is provided as a voluntary contribution by the competent authority in order to promote animal health and ultimately protect consumers.

Verfahrensablauf	<ul style="list-style-type: none"> <li>• Use the form provided by the competent authority to apply for aid and submit it with the required documents.</li> <li>• The responsible authority will examine your application and your documents. If necessary, it will request further documents or information from you.</li> <li>• The competent authority will decide on your application. The competent authority will calculate the amount of aid if necessary.</li> <li>• You will receive a notification from the responsible authority.</li> <li>• For the laboratory diagnostic tests provided by the State Laboratory Institute for Hygiene and Environment, data is exchanged between the responsible body and the Institute for Hygiene and Environment. The aid is paid as a subsidy to the service provider commissioned to carry out the measure. Aid for animal losses is granted as a subsidy directly to you as the aid recipient.</li> </ul>

Aid can not be paid for other animal species.</li> </ul>
