Teaser	If you want to use the professional title "speech therapist", you need a permit.
Volltext	In order to work as a speech therapist in Germany, you need a state permit. You must apply for the permit from the responsible authority. With this permit, you can use the professional title "speech therapist" and work in the profession.
Erforderliche Unterlagen	Copy of the certificate or notice confirming the equivalence of your foreign professional qualification Certificate of good conduct (does not need to be brought along, just applied for, not older than 3 months) If you have a foreign professional qualification, criminal records from all countries in which you have resided in the last 5 years Medical certificate stating that you are not unfit to practice the profession due to health reasons (not older than 3 months) Confirmation of having the knowledge of the German language required to carry out the professional activity (certificate of acquisition of language skills at least at level B2)
Voraussetzungen	After three years of training, you have passed the state examination for speech therapists or your foreign professional qualification has been recognized in Germany. You have not been guilty of any conduct that would render you unreliable to perform your

	profession. You are not unsuitable for the profession due to health reasons. You have the knowledge of the German language required to carry out your professional activities.
Kosten	80 - 200 €
Verfahrensablauf	You submit your application in writing to the responsible authority. The responsible authority will check the completeness of your application and, if necessary, request any missing documents or information from you. The competent authority checks whether the requirements are met. If you meet the requirements, you will receive permission. You may not begin the activity until you have received permission.

Hinweise	Comparable qualifications that you have acquired outside Germany can be recognized as equivalent. If you have a corresponding qualification that was completed outside Germany, you may be able to work as a service provider in Germany temporarily and occasionally without a permit (according to EU law). You must report this to the relevant authority in advance.
Rechtsbehelf	You can raise an objection to a negative decision within one month of notification at the office specified in the letterhead.
Kurztext	In order to work as a speech therapist in Germany, you must apply for a state permit. With this permit, you are allowed to use the professional title "speech therapist" and work in this profession.
