| <b>Teaser</b>                        | If you want to dispose of radioactive residues or waste from the medical, research and commercial sectors, you need a permit to deliver radioactive waste for storage at the state collection point.   |
| <b>Volltext</b>                      | <ul style="list-style-type: none"> <li>• To dispose of or hand over radioactive waste to the state collection point, you require approval from the responsible authority.             <ul style="list-style-type: none"> <li>• If you have the approval, you are responsible for organizing the delivery to the state collection point.</li> <li>• If you transport radioactive waste to the state collection point by road, you must pay attention to the requirements of the dangerous goods law.</li> </ul> </li> </ul> |
| <b>Erforderliche Unterlagen</b>      | <ul style="list-style-type: none"> <li>• Written application for the delivery of solid radioactive substances for storage in the state collection point.</li> <li>• Transport option that meets the requirements of dangerous goods legislation.</li> </ul>  |

| <b>Kosten</b>                        | The costs are based on the current Hamburg environmental fee schedule. In addition, a final storage fee must be paid. Both are calculated according to the volume of the waste per liter. The repository fee is recalculated annually.   |
| <b>Verfahrensablauf</b>              | <ul style="list-style-type: none"> <li>• You fill out the relevant application form completely and send it to the responsible authority.</li> </ul>  |

|                              | <ul style="list-style-type: none"> <li>• The competent authority checks whether the conditions for accepting the radioactive waste are met.</li> <li>• If necessary, the responsible authority will request further documents or information from you.</li> <li>• If all documents are available and the requirements for acceptance are met, you will receive written approval from the responsible authority.</li> <li>• You will then contact the state collection point to coordinate the date and details of the delivery.</li> <li>• If the conditions for acceptance are not met, the responsible authority will ask you to bring the waste into a condition that complies with these regulations.</li> <li>• The notice will be sent to you by email or post.</li> <li>• The fee notice will be sent to you separately.</li> </ul>   |

| Rechtsbehelf                 | Objection within one month of receipt of the decision.<br>The unsuccessful objection procedure is subject to a fee.  |
