Volltext	<p>If you want to employ a pregnant or breastfeeding woman between 8 p.m. and 10 p.m., you must obtain approval.</p> <p>If the supervisory authority does not temporarily prohibit the employment, you may employ the woman between 8 p.m. and 10 p.m.</p> <p>The competent authority may temporarily prohibit you from employing a pregnant or breastfeeding woman during this period in order to ensure the protection of the health of the woman or her child.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • medical certificate • Consent statement of the pregnant or lactating woman. The woman can revoke your declaration at any time. • Evaluation of the working conditions according to § 14 paragraph 1 Maternity Protection Act

Voraussetzungen	<ul style="list-style-type: none"> • You can only submit the application if you are an employer. <ul style="list-style-type: none"> • The pregnant or breastfeeding woman must expressly agree to the planned working hours. • The medical certificate must not speak against employment until 10 p.m. • It is impossible to place a pregnant woman at unreasonable risk by working alone. • There is no risk of irresponsible danger to the child caused by the mother working alone.
Kosten	<p>Fees are charged based on the amount of work involved. Please contact the relevant office to find out about the processing fees involved.</p> <p>The exact costs will be determined after approval.</p>
Verfahrensablauf	<p>You can apply for permission to employ a pregnant or breastfeeding woman between 8 p.m. and 10 p.m. in writing or online.</p> <p>You can request approval in writing:</p> <ul style="list-style-type: none"> • Please describe your request informally. • Send your application, including the required documents and evidence, to the responsible authority. • If necessary, the responsible authority will request further documents or information from you. • The responsible authority will decide on your application. • Your application will be considered approved if you do not receive a rejection within 6 weeks. • If the requirements for approval are not met, you will receive a rejection. • You may receive a provisional rejection. • If your application is rejected, you will receive a rejection letter.
