Teaser	If you employ people who work in a third-party facility with X-ray equipment or stray radiation sources, you must report this in writing. This applies to you if you work in third-party systems yourself.
Volltext	<p>The employment of employees in a third-party facility with X-ray equipment or interference sources without the required display is prohibited. This also applies to you if you work in third-party systems yourself.</p> <p>The obligation to notify does not apply if you already have a license under Section 25 StrlSchG or if it can be ruled out that the people working in the external company will each receive a higher effective dose than 1 mSv in a calendar year.</p>

	<p>radiation protection of these persons.</p> <ul style="list-style-type: none"> • If no radiation protection officers are required or if the radiation protection officer works in an external facility, the applicant's specialist qualification in radiation protection must be presented. • Evidence that the persons otherwise active in the operation of the X-ray facility have the necessary knowledge and skills with regard to the possible radiation hazard and the protective measures to be taken. • Evidence that the persons employed in the company with the external X-ray equipment or stray radiation sources obey the radiation protection officers and radiation protection officers.
Voraussetzungen	You can only apply for a license if you are responsible for radiation protection according to § 69 StrlSchG.
Kosten	The notification is subject to a fee. The fees are calculated according to the time spent in accordance with § 2 of the fee schedule.
Verfahrensablauf	<ul style="list-style-type: none"> • You report the planned activities of your employees in connection with third-party X-ray equipment or sources of interference in writing and informally, including the documents listed in the notification. • If the documents or information required for processing are incomplete, you will be contacted by the administrative department. • The decision will be sent to you by e-mail or by post. • The notice of fees will usually be sent to you later.
