Teaser	If you would like to use the professional title "nurse" or "nursing specialist", you must apply for a permit. You can find out more here.
Volltext	The work of a nurse is regulated in Germany.
	In order to work as a nurse in Germany, you must apply for a state permit. With this permit, you are allowed to use the job title "nurse" and work in the profession.
Erforderliche Unterlagen	 Copy of the certificate or notice confirming the equivalence of the foreign professional qualification Certificate of good conduct (does not need to be brought with you, just apply for it at the city administration) If applicable, criminal records from all countries in which you have resided within the last 5 years, Medical certificate stating that you are not unfit to practice the profession due to health reasons Confirmation of having the knowledge of the German language required to carry out the professional activity (certificate of acquisition of language skills at least level B2) Proof of identity if applicable
Voraussetzungen	 You have successfully completed your state examination in Hamburg. You have not been guilty of conduct that renders you unreliable for the exercise of your profession. You are not unsuitable for the exercise of the profession in terms of health. You have the knowledge of the German language required for the exercise of your professional activity.

Verfahrensablauf	 You submit your application together with the necessary documents to the responsible authority. The responsible authority will check your application for completeness and, if necessary, request any missing documents or information from you. The responsible authority will check whether you meet all the requirements. If you meet all the requirements, you will be granted permission. Otherwise, you will receive a rejection notice. You will also receive a fee notice. You pay the fees.
	You may not begin the activity until you have received permission.

Hinweise	Qualifications obtained abroad must first be recognized.
Rechtsbehelf	You can raise an objection to a negative decision within one month of notification at the office specified in the letterhead.
