Volltext	<p>The work of a nurse is regulated in Germany.</p> <p>In order to work as a nurse in Germany, you must apply for a state permit. With this permit, you are allowed to use the job title “nurse” and work in the profession.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Copy of the certificate or notice confirming the equivalence of the foreign professional qualification <ul style="list-style-type: none"> <li>• Certificate of good conduct (does not need to be brought with you, just apply for it at the city administration)</li> <li>• If applicable, criminal records from all countries in which you have resided within the last 5 years,</li> <li>• Medical certificate stating that you are not unfit to practice the profession due to health reasons</li> <li>• Confirmation of having the knowledge of the German language required to carry out the professional activity (certificate of acquisition of language skills at least level B2)</li> <li>• Proof of identity if applicable</li> </ul> </li> </ul>
Voraussetzungen	<ul style="list-style-type: none"> <li>• You have successfully completed your state examination in Hamburg. <ul style="list-style-type: none"> <li>• You have not been guilty of conduct that renders you unreliable for the exercise of your profession.</li> <li>• You are not unsuitable for the exercise of the profession in terms of health.</li> <li>• You have the knowledge of the German language required for the exercise of your professional activity.</li> </ul> </li> </ul>

Verfahrensablauf	<ul style="list-style-type: none"> <li>• You submit your application together with the necessary documents to the responsible authority.</li> <li>• The responsible authority will check your application for completeness and, if necessary, request any missing documents or information from you.</li> <li>• The responsible authority will check whether you meet all the requirements.</li> <li>• If you meet all the requirements, you will be granted permission. Otherwise, you will receive a rejection notice.</li> <li>• You will also receive a fee notice.</li> <li>• You pay the fees.</li> </ul> <p>You may not begin the activity until you have received permission.</p>
