Teaser	If you hold a fair or weekly market where only a small amount of livestock is sold, you can request that the event not be monitored. To do so, you must submit an application to the relevant authority.
Volltext	Special regulations for the prevention of animal diseases apply to events where livestock is offered or exhibited. Livestock includes all farm animals, such as cattle, pigs, horses, sheep, and goats.
	You can apply for an exemption from these rules for fairs and weekly markets if only a few animals are offered there.

Voraussetzungen	 These are animals that fall into the livestock category. These are farm animals such as cattle, pigs, horses, sheep, and goats. The event is an annual or weekly market. There is only a small amount of trade in livestock.

Bearbeitungsdauer	Processing usually takes 1 to 3 weeks.
Frist	You need an exemption from the official regulations before you can hold the annual or weekly market without these requirements.

Kurztext	 Livestock markets, livestock exhibitions or events of a similar nature are monitored by the competent authority to prevent animal diseases. Annual and weekly markets where livestock is only traded to a small extent can be exempted from surveillance.
