Teaser	If you hold a fair or weekly market where only a small amount of livestock is sold, you can request that the event not be monitored. To do so, you must submit an application to the relevant authority.
Volltext	<p>Special regulations for the prevention of animal diseases apply to events where livestock is offered or exhibited. Livestock includes all farm animals, such as cattle, pigs, horses, sheep, and goats.</p> <p>You can apply for an exemption from these rules for fairs and weekly markets if only a few animals are offered there.</p>

Frist	You need an exemption from the official regulations before you can hold the annual or weekly market without these requirements.
