Teaser	If you wish to organize a dog or cat show or events of a similar nature in a rabies-prone area or with dogs or cats from an EU Member State or third country, you must notify the competent authority beforehand.
Volltext	Special obligations apply to events involving animals. As an organizer, you have to advertise certain dog shows or cat shows. This includes dog shows or cat shows and similar events • in a rabies prone area, • with dogs and cats from EU member states or third countries. The notification must also be made for events when dogs and cats participate together or individually. Under certain circumstances, the competent authority can restrict or prohibit events of this type. This may be necessary, among other things, to combat animal diseases. The competent authority will inform you about the restrictions or bans.
Erforderliche Unterlagen	 Permission according to § 11 Animal Welfare Act (does not apply to non-commercial dog shows or cat shows) for animals from abroad: animal health certificate and supporting documents (proof of vaccination, proof of the result of the blood test) event permit registration number
Voraussetzungen	You need a permit according to § 11 Animal Welfare Act (does not apply to non-commercial dog shows or cat shows)
