Teaser	If you have had a child, you are obliged to submit further information and proof of the birth to the registry office. The hospitals may also forward your documents.
Volltext	You must report the birth of your child to the responsible registry office and submit the required documents.
Erforderliche Unterlagen	You will need the paperwork, evidence and documents that you wish to submit to the relevant registry office.
Voraussetzungen	You have reported the birth of a child to the responsible registry office and would like to submit additional documents to register the birth.

Verfahrensablauf	In order for the birth of your child to be registered, the responsible registry office needs the necessary information and documents from you.
Bearbeitungsdauer	Processing may take a few days.
Frist	If the child was not born in a hospital or birthing center, you must report the birth of your child to the relevant registry office within one week. If your child was stillborn, you must report the birth no later than the third working day following the birth.
