Teaser	If you want to transport people by motor vehicle on scheduled services, you need a permit.
Volltext	You need a permit if you want to transport people by motor vehicle on scheduled services. You must apply for the permit. shipping lines in the traffic area, the latter insofar as they serve commuter traffic When applying for scheduled transport: Overview map showing the area applied for and all existing railways, trolleybus lines, motor vehicle lines and shipping lines in the transport area, insofar as the latter serve commuter traffic If applicable, stop list If applicable, timetable If applicable, list of shareholders If applicable, partnership agreement traffic manager contract Certificate in tax matters from the responsible tax office (not older than three months) Certificate of clearance from all social insurance providers (not older than three months) Certificate of clearance from the professional association (not older than three months) Audited annual financial statements, if applicable, an equity certificate in the year of registration of the company and, if applicable, an additional certificate (not older than one year) If applicable, extract from the commercial register Proof of professional suitability for the passenger transport operator from the Chamber of Industry and Commerce (IHK) Evidence of personal reliability, in particular a certificate of good conduct to be presented to the authorities Where applicable, proof of the public service contract If applicable, information on existing permits If applicable, information on special conditions of carriage If applicable, information on the line-related tariff Where applicable, information on the bindingly guaranteed standards Measures to achieve the goal of complete accessibility Information on compliance with the principles of climate protection and sustainability Description of the improvement in transport service provided by the requested transport business registration vehicle lists If applicable, cooperation agreement If applicable, information on driving and rest times

Voraussetzungen

You can prove your professional qualifications. You can prove the financial viability of your company. You can prove your personal reliability. Your place of business or branch office in question is located in Germany. Your planned route includes only suitable roads. Your project meets the requirements of local transport planning. The planned route takes into account the exclusive rights of other transport companies. Your

	project is in the public transport interest.
Kosten	The amount of the fees varies and depends on: the duration of the permit the total line length the number of daily or weekly trip pairs
Verfahrensablauf	You fill out the application and submit it together with the required documents. The responsible authority will check your application for completeness and will contact you if there are any questions. The responsible authority checks whether the legal requirements are met. The competent authority conducts a hearing procedure with external parties involved (for example with companies that already offer scheduled services, cities, municipalities or districts, trade supervisory authorities and chambers of industry and commerce). If all conditions are met, the competent authority will grant you approval and send you a certificate of approval.
Bearbeitungsdauer	The processing time varies and depends on the individual case.
Frist	Deadlines only begin to run when an application ready for a decision is submitted. If your application is complete, a decision will be made within 3 months. The deadline can be extended by 3 months if necessary. For cross-border scheduled services, the processing period is suspended while contact is being established with the Federal Office for Logistics and Mobility. The period of validity of the permit shall be a maximum of 10 years.

Hinweise	If several companies apply for approval for the same regular service, the approval authority decides in a selection process which application best suits the public transport interest.
