Teaser	If you have a temporary residence permit for mobile researchers, you can apply for an extension if you wish to continue working.
Volltext	If your temporary residence permit for the purpose of research for mobile researchers is about to expire and you would like to continue researching in Germany, you can apply for an extension. To do so, you must prove that your research assignment will continue beyond the current period of validity of your residence permit. If you extend your residence permit, it will be limited again, usually for the duration of your research assignment.
Erforderliche Unterlagen	 Passport or passport replacement Existing residence permit Current biometric photo From May 1, 2025, you must submit your passport photo electronically. You can have the photo taken on-site or bring a QR code, which the photo studio will give you when the photo is taken. 	 rental agreement Proof of livelihood (including proof of income for the last 3 months) Proof of your health insurance
Voraussetzungen	 You have a recognized and valid passport or passport substitute and a valid residence permit for the purpose of research for mobile researchers There is no interest in deporting you. You can secure your livelihood and health insurance coverage from your income without relying on public benefits. You can submit a hosting agreement or a corresponding contract with a research institution to carry out the research project.
Kosten	 Extension for a further stay of up to three months: EUR 96.00 Extension for a further stay of more than three months: EUR 93.00 For express orders, additional charges may apply: 35.00 EUR
Verfahrensablauf	 You use the online service to apply for a residence permit and upload the required documents. The responsible office will then send you an appointment for an interview. Please bring all necessary documents, preferably in original, to the appointment. The responsible authority will check your identity and documents. The competent authority shall involve other authorities where necessary. If your application is approved, your fingerprints and signature will be taken and a biometric photo will be taken to produce the electronic residence permit (eAT). The responsible authority commissions an external agency, the Federal Printing Office, to produce your eAT. As soon as the eAT is ready, you will receive a notification and can pick it up in person from the responsible office. The responsible office will schedule an appointment for you. If the application is rejected, you will receive a rejection notice with the reasons for the rejection.

Bearbeitungsdauer	Processing will begin immediately at the appointment if all documents are complete. The delivery time for the electronic residence permit from the Federal Printing Office is typically two to four weeks.
Frist	Apply for an extension of your residence permit at least 10 weeks before the expiry of the temporary period at the immigration office responsible for your place of residence. The maximum period of your stay may not exceed one year.

Hinweise	As a rule, the residence permit cannot be extended if this was already excluded when the residence permit was issued or when it was last extended.
Rechtsbehelf	contradiction
Kurztext	 Residence permits for research purposes for mobile researchers can be extended if the research assignment is continued beyond the expiry date. Proof of ongoing research assignment required. The extension is again limited, usually for the duration of the research contract.
