Volltext	<p>Guardians can apply for an exemption from compulsory schooling according to Section 39 Paragraph 1 of the Hamburg School Act if</p> <ul style="list-style-type: none"> · the vocational school has been successfully completed or · the child has received adequate education elsewhere within the meaning of the School Act. <p>According to Section 39 Paragraph 2, you can apply for exemption from compulsory school attendance:</p> <ul style="list-style-type: none"> · if an important reason justifies this and · adequate instruction or equivalent support is otherwise guaranteed. <p>It is important that the application be submitted in writing to the school previously attended. The school previously attended is available for advice.</p> <p>Please state in the application the reasons why exemption from compulsory school attendance is necessary.</p>

Verfahrensablauf	<p>You first request a consultation at the school you have previously attended.</p> <p>If the requirements for exemption from compulsory school attendance are met, submit an informal written application to the school.</p> <p>The school administration will review the application and initiate further steps.</p> <p>You will receive a written notification.</p>
Bearbeitungsdauer	The processing time depends on the individual case.
Frist	If possible, two months before the desired exemption from compulsory schooling
