Teaser	If you have been granted a residence permit to seek employment due to the equivalence of your professional qualifications or the granting of a professional practice permit, you can apply for an extension under certain conditions.
Volltext	If, after determining the equivalence of your foreign professional qualification or obtaining a professional practice permit, you have been granted a residence permit to seek employment which is valid for less than 12 months, you can apply for an extension of up to 12 months under certain conditions.
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Valid national passport • Proof of secure livelihood (e.g. employment contract and pay slips, bank statements, declaration of commitment by third parties) • Proof of health insurance • Proof of qualification (certificate of completion, certificate or confirmation from your training company or educational institution about the successful completion of training)

Voraussetzungen	<ul style="list-style-type: none"> • You already have a residence permit for the purpose of looking for a job after a successful recognition procedure for your foreign professional qualification in Germany. <ul style="list-style-type: none"> • Your current residence permit is limited to a period of less than 12 months. • Their livelihood is secure. • Her identity has been established. • You have a valid national passport.
Kosten	<p>96.00 EUR for a further stay of up to three months 93.00 EUR for a further stay of more than three months</p>
Verfahrensablauf	<ul style="list-style-type: none"> • Find out whether the office responsible for your application allows you to submit your application online or has a special application form. In Hamburg, the application can be submitted online. <ul style="list-style-type: none"> • You submit your application. • The responsible authority will examine your application and, if necessary, request any necessary documents or information from you. • The responsible office will contact you to arrange an appointment. • During the appointment, your identity and documents will be checked (please bring your documents, preferably in the original, with you to the appointment). • If your application is approved, your fingerprints will be taken to produce a new electronic residence permit (eAT card). • You pay the applicable fees. • The Federal Printing Office will be commissioned to produce your new eAT card. • Once completed, you will receive information and can collect the residence permit in the form of the eAT card in person. • If your application is rejected, you will receive a rejection letter. In this case, you will also have to pay an administration fee.

Bearbeitungsdauer	You should expect processing to take 6-8 weeks. If you submit all the required documents in full and well prepared, processing may be quicker. After approval, it will then take another 4-6 weeks for the Federal Printing Office to produce your electronic residence permit.
Frist	You must submit your application before your current residence permit expires (4-6 weeks in advance is recommended).

Hinweise	<ul style="list-style-type: none"> • If you do not find a job during the validity of your residence permit, an extension beyond 12 months is not possible. If there is no other reason justifying your stay, you must leave Germany. • This residence permit allows unrestricted employment.
Rechtsbehelf	You can appeal against a rejection within one month of notification.
Kurztext	<ul style="list-style-type: none"> • Apply for residence permit extension to look for a job after professional recognition procedure • Residence permit to seek employment after recognition of foreign professional qualifications or receipt of professional practice permit already granted • Residence permit for job search under 12 months can be extended to up to 12 months upon application
